One of the many things to consider in deportation defense is where and how ICE interacts with a church. Generally, if an area is accessible by the public, ICE can enter without a warrant. In areas that are considered private, ICE is not allowed in without a warrant. Please consult an attorney to learn how your specific church is affected. You can use this sign to designate the private property parts of the church. *Available in English and Spanish.*
